Long term strategic moderate-income positioning and disciplined rebalancing combined with tactical allocation and manager / stock selection provide long term growth potential as well as volatility protection.

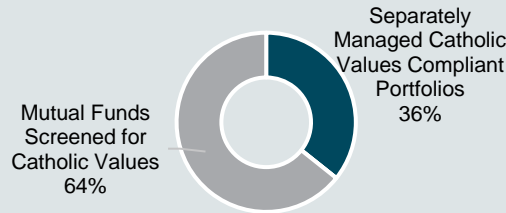

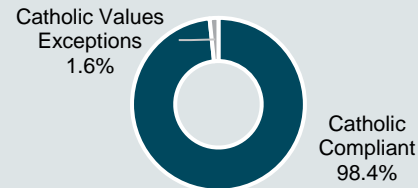
Asset Allocation



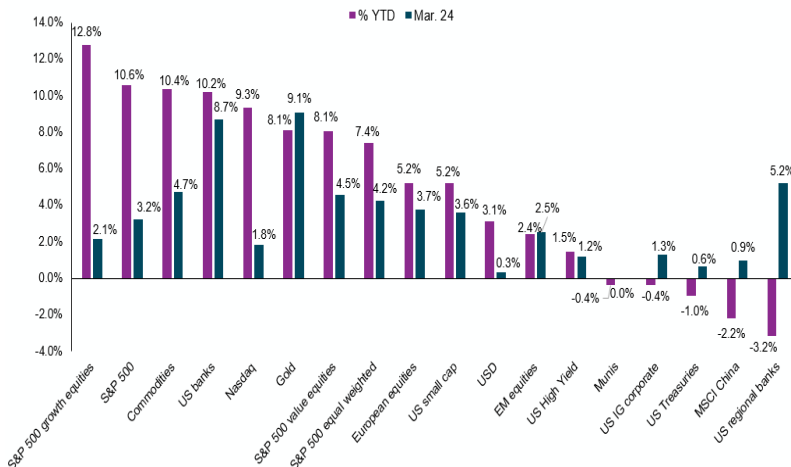

- S&P 500 growth stocks are up 12.8% YTD followed by 10.6% for the S&P 500. In March, small caps gained 3.6%, value was up 4.5%, and the S&P 500 equal weighted was 4.2% higher.
- While lagging the S&P 500 YTD, strong returns across these sectors suggest a broadening rally. After a positive 2023, fixed income is negative to start the year as yields are higher YTD.
- YTD laggards include US regional banks (-3.2%) despite gaining 5% in March and China (-2.2%).
