The intermediate pool's purpose is to maintain the purchasing power of the underlying pool in perpetuity with additional emphasis on downside protection.

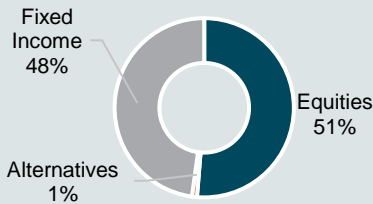
Positioning

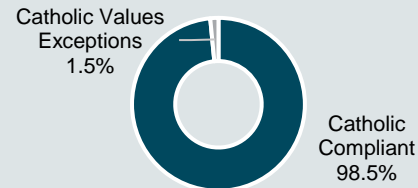
Asset Allocation



Manager Allocation

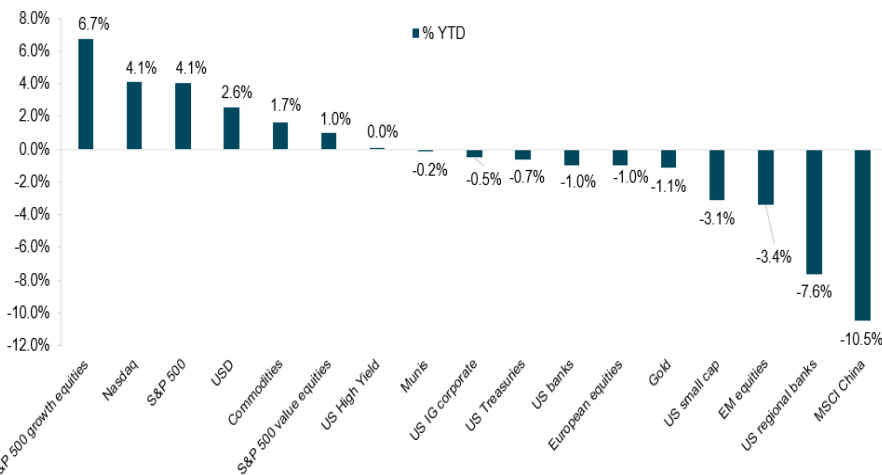

Asset class YTD performance %



- US, growth, and tech stocks' leadership from 2023 has persisted YTD. S&P 500 growth stocks are up 6.7% followed by 4.1% in the NASDAQ and S&P 500.
- The USD is up 2.6% as interest rates have increased and the Fed pushed back on the market's expectations of 5-6 cuts.
- After a positive 2023, fixed income is negative to start the year as yields are higher YTD. YTD laggards include US small caps (-3.1%), emerging market equities (-3.4%) particularly China (-10.5%), and US regional banks (-7.6%).
